The Maria Theresa College of Nursing is an educational institution established, maintained, and administered by the Maria Theresa Hospital Trust, a Charitable Trust. The College of Nursing with an annual intake of 50 students for B.Sc. Nursing was started in 2023. The college is recognized by the Indian Nursing Council (I.N.C.) as well as the Kerala Nursing and Midwifery Council and is affiliated with the Kerala University of Health Sciences (KUHS), Thrissur.

**Instructions to the Applicants**

**General Information**

1. Applications for admission to first year B.Sc. Nursing (academic year 2024-25) in the **seven** seats of the NRI category at this college is being invited on the basis of this prospectus.
2. Details of the admission 2024-25 under the NRI quota are available on the website of the Maria Theresa College of Nursing ([www.mariatheresacon.org](http://www.mariatheresacon.org))

### **Academic Eligibility**

- a) As per norms of Kerala University of Health Sciences (KUHS) for admission for B.Sc Nursing, the minimum educational requirement shall be the passing of Higher Secondary School Certificate Examination (12 years course), or Senior School Certificate Examination (10+2), or Central Board of Secondary Education (CBSE) or Indian School Certificate Examination (ICSE) or an equivalent with 12 years schooling from a recognized board or university with Science (Physics, Chemistry, and Biology) and English).
- b) As per the Indian Nursing Council Norms the candidate should have passed plus two with 12 years of schooling with 50% aggregate in Physics, Chemistry, Biology and English.

### **Eligibility for admission to N.R.I Category Seats**

- a) The eligible candidates for NRI category admission must have passed the Higher Secondary Examination of the Board of Higher Secondary Education of Kerala or equivalent examinations recognized by any of the Universities in the state of Kerala **with an aggregate greater than or equal to 70 % marks in Physics, Chemistry Biology and English in the second year.**
- b) Applicants for NRI seats must be at least **17 years of age on 31<sup>st</sup> December 2024** (the date of birth being shown on the Matriculation or equivalent certificate).
- c) The NRI relative who is sponsoring the candidate should be an Indian Citizen/Overseas citizen of India/Person of Indian Origin and relevant document to prove the same.
- d) According to the GO(MS) No.243/2014/H&FWD dated 06.08.2014, *“An Applicant who depends upon his/her Father / Mother / Brothers and Sisters (inclusive of first cousins) / Husband / Wife / Brothers and Sisters (inclusive of first cousins) of Father or Mother / Half Brother / Half Sister / Adopted Father or Adopted Mother who is working abroad”* will only be eligible to apply in the NRI category seats.
- e) Admission to NRI seats in B.Sc Nursing will be on the basis of the merit list prepared by the college authorities.
- f) The candidate must present himself/herself with all the originals of the required documents on the day of the certificate verification.
- g) The published list will be valid till the cutoff date declared by the statutory bodies for admission to the academic year 2024-2025
- h) The Institution will admit only those students who have complied with all the instructions and according to the information for admission, furnished in the Prospectus for NRI SEATS 2024-2025

### Application Process

#### Submission of Applications

- a) The duly filled application form should be downloaded and submitted together with self-attested copies of necessary certificates and an application fee of **Rs.1,000/- (Rupees One Thousand only)** as DD in favor of Maria Theresa College of Nursing payable at Kuzhikkattussery.
- b) The application fee once remitted is non-refundable, under any circumstances.
- c) The filled-in applications should reach Maria Theresa College of Nursing, Kuzhikkattussery.P.O, Thrissur 680697 no later than **3:00 pm, on 20-07-2024** The applicants, in their own interest, are advised to send the applications by Registered Post. ***The college cannot be held responsible for non-receipt or late receipt of applications, under any circumstances.*** The application form should be completed carefully; furnishing the entire information called for.
- d) Late and incomplete applications and applications not in the prescribed format will be summarily rejected.

**The copy of the following documents shall be submitted with the online filled application form** (The original documents will have to be submitted at the time of admission).

- a) School Leaving Certificate (S.S.L.C.) of student establishing that the student has completed 17 years of age as on 31-12-2024.
- b) HSE or equivalent examination mark-sheet / pass certificate.
- c) A statement to show that the high school in which the student has studied has been accredited by the State/Country/University (**if applicable**).
- d) Equivalence Certificate from Association of Indian Universities (**if applicable**).
- e) Eligibility certificate from Kerala University of Health Sciences (**if applicable**).
- f) Copy of the Overseas Employment Certificate issued by the employer, attested by the Embassy OR if self-employed, a statement in this regard that is duly attested by the Embassy.
- g) Copy of the relevant pages of the passport containing visa details that are attested by the Embassy.
- h) Sponsorship Certificate -The NRI relative who is sponsoring the candidate should be an Indian Citizen/Overseas citizen of India/Person of Indian Origin and a relevant document to prove the same.

- i) The Candidate shall produce the sworn affidavit (*find specimen format Annexure-1*) from the Sponsor in a stamp paper worth Rs. 200/-. The same shall also be notarized by the Notary Public, disclosing that the student is dependent on the sponsor and that all expenses i.e. tuition fee and special fee, of the candidate for the entire course period will be borne by the Sponsor.
- j) Relationship Certificate to be issued by the Revenue Authorities to prove the relationship between the candidate & the NRI relative as per GO(MS) No.243/2014/H&FWD dated 06.08.2014.
- k) Two hard copies of the submitted online application form

### **Original documents to be submitted at the time of admission**

The following documents and two set of copies of certificates duly attested by a Gazetted Officer shall be submitted

1. Overseas Employment Certificate issued by the employer, attested by the Embassy OR if self-employed, a statement in this regard that is duly attested by the Embassy.
2. The relevant pages of the passport containing visa details that are attested by the Embassy.
3. The NRI relative who is sponsoring the candidate should be an Indian Citizen/Overseas citizen of India/Person of Indian Origin and relevant document to prove the same.
4. The Candidate shall produce the sworn affidavit (*find specimen format Annexure-1*) from the Sponsor in a stamp paper worth Rs. 200/-. The same shall also be notarized by the Notary Public, disclosing that the student is dependent on the sponsor and the all expenses i.e. tuition fee and special fee, of the candidate for the entire course period will be borne by the Sponsor. (Sponsorship Certificate).

### **Conversion of NRI seats to open merits under management quota**

Unfilled seats if any under the NRI quota will be reverted to the open merits under the **management quota**

### **Remittance of Fee**

The candidates selected under the NRI category are required to remit the prescribed fee for the first year of the course within the duration of four days of selection by way of DD or NEFT.

If any candidate fails to complete the admission procedure under the NRI seats within four days, those candidates will be considered as declined to join the BSc Nursing course 2024-2025

In the above circumstances, the vacant seats will be filled by the candidates on the waiting list or by new applicants

### **Discontinuation of the course**

If any student discontinues the course, after the closing of admission as notified by the statutory authority, the candidate will have to pay liquidated damages equivalent to the tuition fees for the remaining period of the course. (4 years) Any complaints in this regard shall be subject to legal and factual scrutiny and the decision of the ASC/FRC.

### **Other information**

- a) All students who get selected should get themselves vaccinated against Hepatitis before admission. A certificate to the effect shall be produced at the time of admission or before the commencement of the course.
- b) Every student is required to adhere strictly to the Code of Conduct of the college.
- c) Ragging is strictly prohibited. If it is found during the admission or any time thereafter that the applicant has indulged in ragging in the past, admission may be refused or the student shall be expelled from the institution. Whoever commits, participates in, abets, or propagates ragging within or outside the institution shall be suspended from the institution with immediate effect and the principal shall report the matter to the civil/police authorities.
- d) Without prejudice to the directions of the Nursing Councils/Government/University, the decision of Maria Theresa College of Nursing shall be final on all matters with regard to admission.
